We close this 90th anniversary year of the founding of the American Board of Pediatrics (ABP) with heartfelt gratitude to board-certified pediatricians like you, your patients, their parents and caregivers, and all who aspire to excellence in their care of our most precious asset — our children. A special note of appreciation is also due to our dedicated and talented employees for another year of progress for which we are most proud.

It has been a distinct honor to serve as the Interim President and CEO of the ABP these past months (see page 14). Although taking on this role has been an experience I never expected, I have been incredibly grateful for the opportunity to serve during the search for new leadership. The depth and breadth of our employees' and volunteers' commitment to the vision and mission of the ABP has been a constant source of inspiration.

Below are just a few observations regarding the scope and scale of work accomplished in calendar year 2023. ABP staff and volunteers:

- Administered nearly 6,000 general pediatrics and subspecialty pediatrics certification exams (see page 5);
- Administered in-training exams to more than 16,000 trainees:
- Celebrated approval of our 100th Pediatric Portfolio Sponsor for Maintenance of Certification (MOC) Quality Improvement (Part 4) activities (see page 10);
- Oversaw 32 question-writing cycles participated in by more than 275 volunteer pediatricians from across the United States; and
- Collaborated with dozens of national volunteer colleagues to write a comprehensive current and future pediatric subspecialty workforce report to be published in *Pediatrics* in February 2024.

The work of the ABP must evolve in concert with changes in child health and with changes in the practice of pediatric medicine. Recognizing this, the ABP has embarked on a comprehensive strategic planning process, launched with a retreat in early 2023 that brought together more than 50 leaders in pediatrics, child health, and health care.








GENERAL PEDIATRICS EXAM:First-Time Takers' Pass Rates Over Time




2023 MOCA-PEDS PARTICIPATION

MOCA-Peds is the ABP's online, non-proctored longitudinal assessment of pediatric medical knowledge, developed as an alternative to the proctored exam given in a secure testing center. MOCA-Peds assessments are continuous during the first four years of an MOC cycle and available for General Pediatrics and every pediatric subspecialty administered by the ABP.

Achieving a passing score in MOCA-Peds during one's Maintenance of Certification (MOC) cycle meets the exam requirement (MOC Part 3) and provides Self-Assessment (MOC Part 2) credit. To the right and below, MOCA-Peds participation for MOC Part 3 credit in each certification area is shown. Meaningful participation is defined as answering at least 80% of MOCA-Peds questions in 2023. Individuals taking MOCA-Peds in more than one area are counted respectively in each area.




PEDIATRIC SUBSPECIALTIES: MOCA-Peds Part 3 Participation





2023 MOCA-PEDS PASS RATES

Although most pediatricians and pediatric subspecialists pass MOCA-Peds and receive MOC Part 3 credit at the end of their third year of participation, participants can take up to four years to complete the requirement. Because of this flexibility, final pass rates for MOCA-Peds cohorts are determined four years after the cohort began. In 2023, final pass rates are available for the cohorts who started MOCA-Peds in 2020. MOCA-Peds pass rates are based on those who meaningfully participated for MOC Part 3 credit. Meaningful participation is defined as answering at least 80% of MOCA-Peds questions during the individual's scoring period.



PEDIATRIC SUBSPECIALTIES: 2020–2023 MOCA-Peds Cohort










MOST POPULAR MOC ACTIVITIES



board-certified pediatricians to earn MOC Part 4 credit for
their local improvement work and allows organizations to

ABP NAMES DR. MICHAEL BARONE AS NEW PRESIDENT, CEO

The ABP selected board-certified pediatrician Michael Barone, MD, MPH, as its next President and CEO. Dr. Barone will succeed Interim President and CEO John Barnard, MD, on March 25, 2024.



Dr. Barone brings to the ABP a unique blend of clinical expertise, educational leadership, and a deep commitment to advancing pediatric health care.

Barone became board-certified in General Pediatrics in 1994 and started volunteering with the ABP in 2014. He served on the Education and Training Committee for eight years and on the ABP Board of Directors from 2016 to 2017. He has maintained his board certification through the years.

TWO-PART QOW SERIES HIGHLIGHTS CYSTIC FIBROSIS

The ABP released a special twopart QOW series in September, ushering in Newborn Screening Awareness Month. This series aims to elevate awareness around cystic fibrosis (CF).



The first question describes the history of CF and how the management has changed, while the follow-up question explores how CF transmembrane conductance regulator (CFTR) modulators can vary in efficacy based on genetic ancestry, which is different from, but related, to demographically assigned race and ethnicity.

"I really believe that in combination, this series will increase both current understanding of the treatment of CF as well as the importance of diagnosing individuals who identify as BIPOC and decreasing the health inequities that continue to occur," says Dr. Jennifer Taylor-Cousar, MD, MSCS, a CF expert and Professor of Internal Medicine and Pediatrics at National Jewish Health and the University of Colorado Anschutz Medical Campus.

NEW DATA-COLLECTION PIM AIMS FOR HEALTH EOUITY IN PEDIATRICS

The ABP launched a new Performance Improvement Module (PIM), "Optimizing the Collection of Race, Ethnicity, and Language Preference



Data," designed to increase health equity in child health care by increasing the collection of race, ethnicity, and language preference data in pediatric clinical settings.

Health disparities related to race and ethnicity are pervasive across medicine, including pediatrics. Pediatricians can help overcome these disparities by better understanding the racial and ethnic diversity of their patients.

"This PIM emphasizes the significance of self-reported patient race, ethnicity, and language data," says Keith Mann, MD, MEd, ABP Vice President for Continuing Certification. "The patients' self-reported data are instrumental in helping clinics and health care systems identify patient populations and measure outcomes to ensure health equity."

Through this PIM, pediatricians will learn strategies to educate families about the need for data collection, methods to understand family and staff experiences with data collection, and opportunities to enhance the completeness of the collected data.


ABP REVAMPS PRIVACY POLICY FOR GREATER UNDERSTANDING, CONSENT

The ABP expanded its Privacy Policy to enhance transparency and provide a more complete picture of how the ABP uses individuals' data in response to evolving privacy laws and third-party contractual agreements. The revised policy covers all interactions with any of the ABP's electronic solutions (e.g., websites, applications, emails, and voice mails).

Individuals who use the ABP website and any portals, software, or electronic solutions made available by the ABP consent to the privacy policy through their participation. The ABP encourages individuals to check the policy periodically for updates.

QUESTION OF THE WEEK CELEBRATES 10 YEARS, 500 QUESTIONS


Question of the Week (QOW), easily one of the most popular activities offered by the ABP, celebrated its 10th anniversary in December. With more than 26,000 board-certified diplomates earning credit through QOW, the



activity helps pediatricians stay up to date with the current literature while learning about common topics and earning MOC Part 2 points.

"You can read the case studies and answer the questions anywhere and anytime," says James Stockman III, MD, editor-in-chief of QOW and former President and CEO of the ABP from 1992 to 2013. "As long as you can access the internet on your computer or laptop, you can be working at your desk, in the clinic, or from your home."

The activity hit another significant milestone just weeks before, when on Nov. 8, its 500th question was published. QOW continues to provide the opportunity to earn MOC Part 2 credit to the more than 31,000 pediatricians currently enrolled in it.

NAVIGATING HEALTH CARE BARRIERS: FOCUS OF 2023 STOCKMAN LECTURE

As presenters of the 10th Annual Stockman Lecture at the American Academy of Pediatrics (AAP) National Conference and Exhibition in October, Jonathan Webb, MPH, MBA, a member of the Family Leadership Committee at the ABP, and his son, Jackson Webb, described the challenges they faced during their six-month search for a diagnosis of Jackson's condition.

"I don't know for sure when it started, but I remember having less energy and a strange feeling in my hands and feet," says Jackson Webb. "It felt like they were constantly buzzing. I also remember falling more, and my legs would buckle when I would run or jump. The worst thing was trying to climb stairs. I just couldn't do it anymore."

Although Jonathan Webb says their pediatrician was "incredibly supportive," their journey required specialists — some more supportive than others — and countless hours of research and persistence.

At different times in their journey, they faced disbelieving physicians, an interruption of insurance coverage, and, once insured, continuous battles to get treatments approved by the payor. They were further hindered by scheduling difficulties, the perceptions of others about their family, and other human and bureaucratic roadblocks.

The ABP celebrated its 90th Anniversary, commemorating nearly a century of work dedicated to promoting excellence in medical care for children and adolescents.



As the ABP looks to the future, its focus has extended to critical areas like behavioral and mental health, health equity, and the practical implementation of entrustable professional activities (EPAs) in training programs.

ABP HONORS DR. GLENN FLORES WITH DAVID G. NICHOLS HEALTH EOUITY AWARD

The American Pediatric Society (APS), in conjunction with the ABP Foundation, announced **Glenn Flores, MD**, as the 2024 David G. Nichols Health Equity Award recipient.



The award was created to recognize demonstrated excellence in advancing child and adolescent health, well-being, and equity through quality improvement, advocacy, practice, or research.

Dr. Flores was recognized for his outstanding commitment to achieving equity and eliminating disparities for the most underserved patients and families and the far-reaching impact of his work. The award will be presented to Dr. Flores during the APS Presidential Plenary at the Pediatric Academic Societies 2024 Meeting in Toronto, Canada, May 2–6, 2024.

ABP LAUNCHES NEW SUPPORT FAQS, IMPROVES SEARCH

Pediatricians and other abp.org visitors now have access to more online tools to help them find information about becoming or remaining certified. The new tools include a Support webpage with searchable, frequently asked questions (FAQs) and an improved Search Results page.

The new Support webpage includes contact information for those who prefer personal service and an initial list of the ABP's most received questions. A search box and topic filters on the page will generate additional FAQs based on inputs from the webpage user.

"Our website improvements have come after several years of learning from trainees, board-certified pediatricians, and ABP volunteers about how they would like to find information on the site," says Mike Adams, MS, Director of Communications at the ABP. "We can't thank them enough for helping us to continuously improve — by



making suggestions and reviewing our designs as the work progressed."

In addition to the Support page and Search Results page, other website improvements in the past year include "mega menus" at the top of each page, an expanded footer, improved mobile menus, increased page contrast, and a stronger infrastructure.

ABP ADDS NEW MOC ACTIVITIES FOR 2023

Each year, the ABP adds new activities to its Maintenance of Certification (MOC) options. While some of the activities replace previous activities of the same name, others are new activities based on patient or health care trends in the United States. All ABP activities are included as part of MOC enrollment. To find them, log into your ABP Portfolio, and choose Part 2 or Part 4 Activity Search.



PEDIATRIC SUBSPECIALISTS MAP MILESTONES TO EPAS

ABP volunteers — subject matter experts in their respective pediatric subspecialties — finalized mapping the new pediatrics milestones 2.0 to the ABP's entrustable professional activities (EPAs), continuing the move



toward a competency-based approach to education and assessment. More than 140 board-certified pediatricians, representing 15 subspecialties, were involved in the project.

The implementation of EPAs and the principles of competency-based medical education (CBME) will help educators provide a more comprehensive approach to education and assessment during training.

"Mapping the milestones to the EPAs is an important step in helping create a shared understanding of the overall competency-based assessment framework," says David Turner, MD, ABP Vice President for Competency-Based Medical Education (CBME). "But our work isn't done, of course. This mapping is just one part of a much larger effort to integrate EPAs and the principles of CBME into the fabric of both training and certification processes."

TRAINING PROGRAMS TO ADMINISTER SITE IN-HOUSE


Beginning in 2024, the Subspecialty In-training Examination (SITE) will transition away from delivery at Prometric Testing Centers and will move to in-house administration by pediatric subspecialty training programs. This means fellows from more than 1,000 training programs will no longer have to travel to a Prometric Testing Center.

"In the past, they've had a lot of issues," says Dr. Lindsay Rogers, MD, MEd. "They were very happy to now have it here - at their own hospital - and not have to go anywhere. And it allowed us to create dates that would fit into many different fellows' schedules."

Dr. Rogers, the Program Director of the Pediatric Cardiology Fellowship Program at the Children's Hospital of Philadelphia (CHOP), participated in the ABP's pilot program.

ABP EXECUTIVE VICE PRESIDENT NAMED TO ABMS BOARD OF **DIRECTORS**

Suzanne Woods, MD, Executive Vice President for Credentialing and Initial Certification at the ABP was elected to the Board of Directors of the American **Board of Medical Specialties**



Dr. Woods, who joined the ABP staff in 2018, continues as Executive Vice President at the ABP, overseeing the development of training standards, the tracking and evaluation of residents and fellows, and the credentialing for and administration of examinations. She also serves as the ABP's liaison to several organizations with common interests in graduate medical education.

In addition to Dr. Woods' appointment, ABMS also elected Rebecca L. Johnson, MD, as the new Board Chair and two other board members: Robert R. Gaiser, MD, and Tara B. Rouse, MA, a former ABP volunteer for seven years.

ABP ANNOUNCES JOHN A. BARNARD, MD, AS INTERIM PRESIDENT, CEO

The ABP appointed John A. Barnard, MD, as Interim President and CEO in June.

Dr. Barnard, who served as Chair-Elect of the ABP's Board of Directors, assumed the role formerly held by outgoing President and CEO Judy Schaechter, MD,

PEDIATRICIANS EARN SURPRISE MOC CREDIT FOR QUALITY IMPROVEMENT (QI) PROJECTS

The ABP pleasantly surprised 727 board-certified pediatricians at the Pediatric Academic Societies (PAS) annual meeting by granting them "instant" Maintenance of Certification (MOC) credit for their health care QI work.

When a poster described a project that met requirements for Quality Improvement (MOC Part 4), an ABP staff member sometimes referred to as the "MOC credit fairy" — gave the lead author a printed card to notify them about the 25 points credit, which is half of the five-year requirement to maintain certification.

The 727 board-certified pediatricians who received credit were represented by 213 posters and 22 oral abstracts.

Many of the posters and abstracts presented at PAS represented the work of several physicians who participated in either a large QI project with their institution or who developed their own QI project at their practice or clinic.

ABP ANNOUNCES CALL FOR COMMENTS ON STRATEGIC PLAN UPDATES

The ABP opened a call for comments in the spring on proposed updates to its organizational vision, mission, values, and goals as part of its strategic planning process.

The ABP sought input from board-certified pediatricians, health care professionals, the public, and other stakeholders to ensure that the organization's strategic plan is both inclusive and comprehensive. The open call served as an opportunity for stakeholders to provide valuable feedback on the proposed updates, helping the ABP to better serve the pediatric community and promote the highest standards of care.

ADDITIONAL SECURITY NOW OFFERED FOR ABP PORTFOLIO LOGIN

To increase the security of board-certified pediatricians' and pediatric trainees' personal data, the ABP in March deployed a new feature in the ABP Portfolio that allows users to choose one or more additional methods of verifying their identity.

With the new security feature, called multi-factor authentication (MFA), those who choose to participate provide that additional means of verification by typing in a code before they log in to their ABP Portfolio. Although participation in MFA is optional at the ABP at this time, the extra step would increase the security of the participant's ABP Portfolio.

NEW MEMBERS JOIN BOARD OF DIRECTORS. OTHER LEADERS EMBRACE NEW ROLES

Leadership at the ABP changed hands in January 2023 as some members of the Board of Directors completed their appointments and were replaced by new members, while some individuals assumed new roles.

The 15-member Board of Directors is composed of pediatricians — in education, research, and clinical practice - and nonphysicians who have a professional interest in the health and welfare of children and adolescents. The Board guides the direction of the ABP toward its vision of improving health outcomes for children, adolescents, and young adults.

New members of the Board of Directors in 2023 are Terry Noah, MD, and Robert Vinci, MD.


